

SUBMITTING A CLAIM

If you believe that you are owed money by a company to which Waterstone has been appointed liquidators, receivers or voluntary administrators, you need to file your claim with us by filling out a proof of debt form.

If you are an unsecured creditor, you need to complete the unsecured creditor's claim form.

If you are a preferential creditor, you need to complete the unsecured creditor's claim form setting out clearly the amounts that you claim is preferential and unsecured (if any).

If you are a secured creditor, being a creditor with the benefit of a security interest over some of the assets of the company in liquidation, you need to file a secured creditor's claim form.

These forms can be downloaded from our website under the [contact section](#). Alternatively, please email reception@waterstone.co.nz to request one.

Once the form is completed please ensure that you have attached all appropriate supporting documentation, for example if the amount is a trade debt please attach a statement of account and all outstanding invoices; if you are a secured creditor please attach the security documents and valuation of your security; If your claim relates to money owed to you as a staff member of the company please include your latest payslip and if possible a copy of your employment contract. If you believe you may be a secured creditor include all documents that evidence the security (for example your signed terms of trade or loan documentation).

Once you have filed your claim you will receive confirmation that your claim has been lodged in the liquidation within 5 working days. If for some reason you do not receive this notification, please contact us immediately.

LIQUIDATION INFORMATION

As liquidators we file periodic reports on the progress of the liquidation. These reports are your way of receiving updates on our progress. These can be viewed on the [NZ Companies Office register](#). Simply search the company name in the search box. Under the various tabs you will find information about the company including details of company directors, shareholders, and the liquidators that have been appointed. To view and download the liquidators reports and appointment documents go to the documents tab.
